## **GENERAL HISTORY**

## A Note on production and delivery of aircraft for the Marine Luchtvaart Dienst

The M.L.D. order for the ST-M2 was composed of a total of five separate contracts, covering 48 aircraft and 12 sets of floats, and was built as 18 in November, 1940 followed by 12 in December and 18 in January, 1941. The first contract was for 12 aircraft [S-11 to S-22], and dated 25 Jun 40. The second contract was supplementary and called for 12 sets of floats and was followed by the third contract, dated 08 Jul 40, for a second batch of 12 aircraft [S-23 to S-34]. On 15 Aug 40, the fourth contract was placed for another 12 aircraft, with a stipulated delivery time of 180 days [S-35 to S46]. The fifth and last contract, date unknown, was also for 12 aircraft and this stipulated a delivery period of 210 days [S-47 to S-58]. Aab Gerben Tornij identifies the aircraft on the first order specifically as type STM-E2. Iac

Airframe identification numbers were 447 to 494 and M.L.D. serial numbers allotted were S-11 to S-58. Xrp, Aaa, Aab

The first 12 M.L.D. aircraft were shipped from Los Angeles [ref. Iac states port as San Diego] on 18 Nov 40 on the s.s. Hoegh Silver Dawn and delivered at Sourabaya on 03 Jan 41. The next 8 were shipped on the m.s. Java on 07 Dec 40 and arrived on 22 Jan 41; they were followed by an additional 4 on the m.s. Klipfontein on 21 Dec 40. The next 7 were shipped in October 1940 followed by 13 in November and 12 in December, the remainder leaving for the N.E.I. in January, 1941. Aaa

The M.L.D. were loaned four K.N.I.L.-M.L. Ryans on 20 Nov 40, for familiarisation with the type. These aircraft, ain 417 as RO-20, ain 425 as RO-28, ain 427 as RO-30 and ain 440 as RO-43 were returned on 11 Feb 41. Aab

One history Aaa notes the following in regard to the M.L.D. use of the type. To the outbreak of war (08 Dec 41) 8 Ryans had been lost two were results of fatal accidents (02 Aug 41 & 10 Aug 41) and S-43 had been destroyed by fire (xx Oct 41). Between outbreak and 16 Feb 42, another seven were lost - two due to attacks by Japanese forces (03 Feb 42). There is the very strong possibility that a number of these Ryan losses were, in fact, Dutch Army aircraft. On 17th February, the remaining 34 aircraft were shipped aboard m.s. *Tjinegara* to Australia where they were operated for a short time by the M.L.D. When Dutch flying training was transferred to Jackson,

Mississippi the Ryans were transferred to the R.A.A.F. The account to this point has little veracity. It is known that a minimum of 37+ aircraft were shipped to Australia, some Dutch records indicating that only a total of seven were lost between their receipt and evacuation to Australia - so four aircraft are effectively "in limbo" until such time as Dutch records can be thoroughly researched.

Recorded<sup>Aaa, Aab</sup> but unidentified M.L.D. losses include :

- (1) 02 Aug 41 site not given : fatal accident almost certainly (a) below
- (2) 10 Aug 41 site not given : fatal accident
- (3) undated Surabaya Bay: (floatplane) Lt. Earl Lee, USN was instructing a student-pilot in touch-and-go landings; attacked by a Japanese *Val* just above the water hit and sank instructor and pupil swam ashore this may be (b) below
- (4) undated site not given: (floatplane) Lt. Earl Lee, USN with student under instruction, caught at 7000' by Zero forced down to sea-level and shot up, the student being killed Lee landed the very damaged a/c on a paddy-field this may be (c) below
- (5) 03 Feb 42 site not given: 2 a/c, to Japanese attack these almost certainly (d) delow
- (6) xx Feb 42 site not given: "a Javanese pilot" took up a seaplane trainer and deliberately engaged a Zero he crashed the Ryan into the Zero both pilots were killed: there is the distinct possibility that this is an "apochryphal"!

Various items from Dutch source<sup>Xrp</sup> shew these unidentified losses:

- (a) 02 Aug 41 nr. Surabaya floatplane: this most likely (1) above
- (b) 21 Jan 42 nr. Madioen landlane: this may be (3) above
- (c) 25 Jan 42 nr. Madioen landplane: this may be (4) above
- (d) 03 Feb 42 at Morokrembangan two destroyed by Jap bombing: this almost certainly (5) above

Of the aircraft that escaped to Australia, it is noted in one or two works (generally of Dutch origin), that they continued in use by the Dutch in Australia prior to hand-over to the R.A.A.F. Allowing known dates, this would have been for a very short period if this actually happened at all. The comment is made by Carpenter & Mayborn (noted above), and may in turn be a repitition of a note by Hugo Hooftman that "The entire training school with 305 student-pilots were (in) February 1942 re-accommodated on two airfields around Melbourne." There is some possible confirmatory evidence in the form of three individual photographs that depict Ryans in full Dutch markings at R.A.A.F. airfields in Australia; these are still the source of some puzzlement.

is not known how many others - if any - were left behind. It is also certain that 37 identifiable airframes escaped to Australia, with a possibility of at least one other, thus thus leaving either three or four unaccounted for.

## The R.A.A.F. Use of the Ryan ST-M2

The tale of the Ryan in R.A.A.F. service is exceptionally hard to unravel in regard to their history to the point of entering service. Whilst various sources quote either 33 or 34 aircraft being loaded on board the m.v. *Tjinegara* at Surabaya for evacuation by 17 Feb 42, there is documented evidence that confirms 36 (possibly 37) individual airframes arriving in Australia. A clear understanding of their delivery port is yet to be ascertained; it is known that by late May/early June 1942 the Ryans were in the hands of the Qantas workshops at Mascot, and erection had commenced. The first 28 aircraft for the R.A.A.F. were completed by Qantas, the remaining six by Australian National Airways. On the assumption that at least some small quantity of spares may have accompanied the aircraft (or alternately, a consideration that at least one or two additional examples of this type may have arrived here, in the form of complete aircraft or salvaged wrecks), we have the knowledge that certainly two and possibly three spare airframes were on hand after the 34th had been assembled. The R.A.A.F. machines were serialled as A50-1 to A50-34, and all have been acceptably identified *in re* their former Dutch serial numbers with the exception of A50-19. It is this machine that causes doubt as to the exact number received. Three "spare" airframes (which may include A50-19) achieved civil registration. The table below shews in simplified form the known fates of the entire 48 Ryan ST-M2 group, as:-

#### No. 457 Squadron

At least one Ryan appears to have been used by No. 457 Sqn. during their working-up phrase at Bankstown, N.S.W. - available illustration shews the machine as camouflaged, in Dutch markings and serialled as "S-54" which became A50-26.

#### Disposing of the type

As the 'War began to reach its finality, a number of types considered as obsolete - including the Ryan ST-M2 - were withdrawn from service and stored; these formed part of a considerable number of surplus aircraft which were disposed of before the end of the 'War. On 20 Sep 44, the Commonwealth Disposals Commission had enquired of the Department of Air in regard to the types and quantities of aircraft likely to be released in the post-war period. This enquiry elicited a reply on 28 Oct 44, in which details of the first aircraft and engines to be released were given. 24 Ryans and 17 spare Menasco Pirate engines were listed for disposal Cac , and 23 aircraft and 16 engines appeared on the first tender issued by the C.D.C., which closed on 20 Feb 45. 14 of these were in N.S.W., the majority at Evans' Head, with 8 in South Australia and one in Tasmania. 15 Nov 44, the D.C.A. had received at least one enquiry concerning the post-war use of this type, from an M.Pengilley of 91 Queen St., Ashfield, N.S.W.<sup>Cae</sup>

## Airflite, Ltd. :

Advising the C.A.B. of their intention to import an example of the type, Airflite requested allotment of registration in May, 1937. On the 11th, VH-UYN was issued for this aircraft. iv

## Brown & Dureau Ptv., Ltd.: [Aircraft Service Depot, Belmont Common Aerodrome, Geelong, Vic.]

Shortly after their purchase of the Ryans, Brown & Dureau suffered a set-back to their plans. This took the form of a violent storm which destroyed a hangar at Evans Head on 7th April, in which nine of the Ryans had been stored. Brown & Dureau advised the D.C.A. (12 Apr 45) "three of the aircraft received only superficial damage, and can readily be made airworthy. The remaining six aircraft, however, sustained major damage in varying degrees. It is probable that we will not make any attempt to rebuild these aircraft, but will salvage undamaged items such as engines, wheels, shock struts, etc. A final decision will be made on this point when we receive more detailed reports." The aircraft with only minor damage were recorded as A50-14, -17 and -29; those with major damage were A50-18, -23, -24, -25, -30 and -34. Cbj

Brown & Dureau wound up their Geelong operations (exact date unknown) and sold their workshops, etc. to Corio Air Engineers, which see for later data.

## <u>Corio Air Engineers</u>: [Belmont Aerodrome, Geelong, Vic.]

On taking over the workshops, *etc.* of Brown & Dureau, applied for D.C.A. approval to operate on 15 Apr 48. This approval, Ref. No. 332, was issued on 01 Oct 48, naming David John Bourke as Chief Inspector for the company.
